Emissions Trading System Simulation in Colombia

September to October 2020

Description:

The Colombian National Government is in the process of designing a National Program for Tradable Emission Quotas (PNCTE). As part of the preparatory phase for its implementation, capacity-building initiatives are being carried out with the support of the World Bank's Partnership for Market Readiness.

The Emissions Trading System (ETS) simulation was a project with a theoretical and a practical component that aimed to:

- 1. Increase the familiarity of the participants with the concepts and mechanics of an ETS, thus strengthening the public-private dialogue in relation to the design and implementation of the ETS.
- 2. Improve the capacity of the private sector to identify needs to comply with an ETS.
- 3. Improve capacities for decision-making under different scenarios of an ETS.

In total, there were more than 270 participants trained in the use of CarbonSim, the carbon market simulation tool, over the course of a two-month period.

Participation criteria:

- Participants made a commitment to complete the full training program.
- Interested participants from the government, private, social, academic, and consultant sectors were selected.
- Priority for registration was given to participants from the private sector, particularly those sectors to be regulated by the PNCTE.

• Participants were recommended to be chosen from different areas within companies with complementary profiles (financial, corporate administration, sustainability, environmental regulatory compliance, etc.)

Training program:

The program included six online sessions over eight weeks and a total of 12 hours minimum to participate in all activities.
