NOTICE OF NAME CHANGE

Intervenor the Association of Global Automakers, Inc. (“Global Automakers”) hereby gives notice to the Court and all parties to this action and all cases consolidated herewith that, as a result of a corporate restructuring and combination consummated on December 31, 2019, Global Automakers has changed its corporate name to the Automotive Regulatory Council, Inc., effective January 2, 2020.¹ See Exhibit 1, Va. State Corp. Comm’n, Certificate of Amendment. Global Automakers thus respectfully requests that this Court substitute its new and proper name, “Automotive Regulatory Council, Inc.,” for “Association of Global Automakers, Inc.” in the above-captioned case and consolidated cases.
