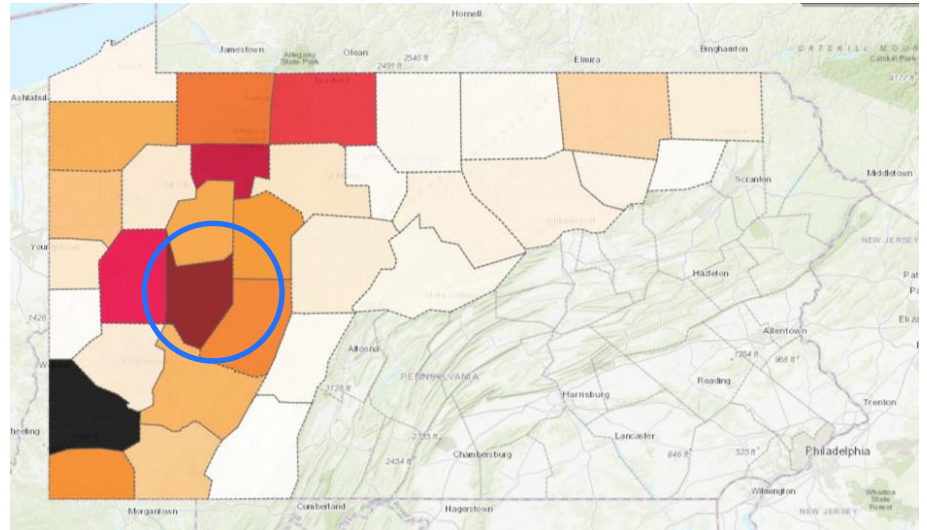
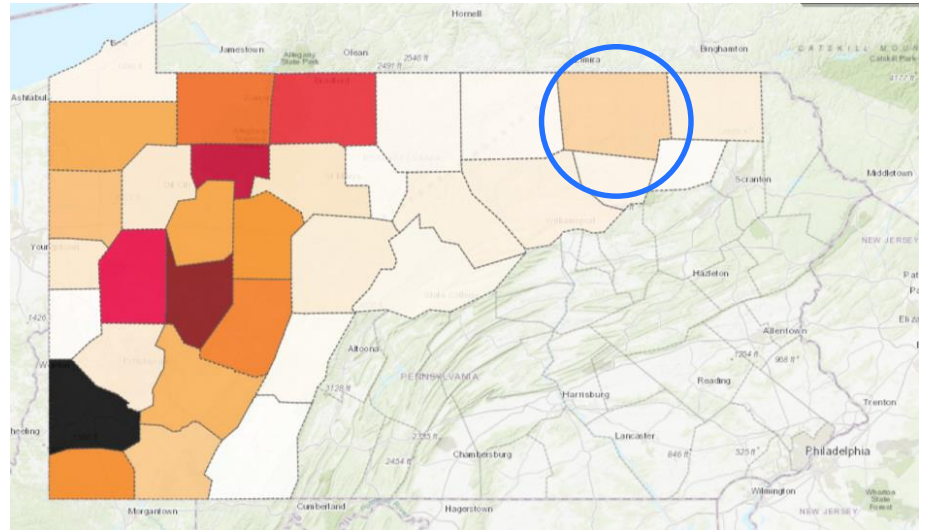

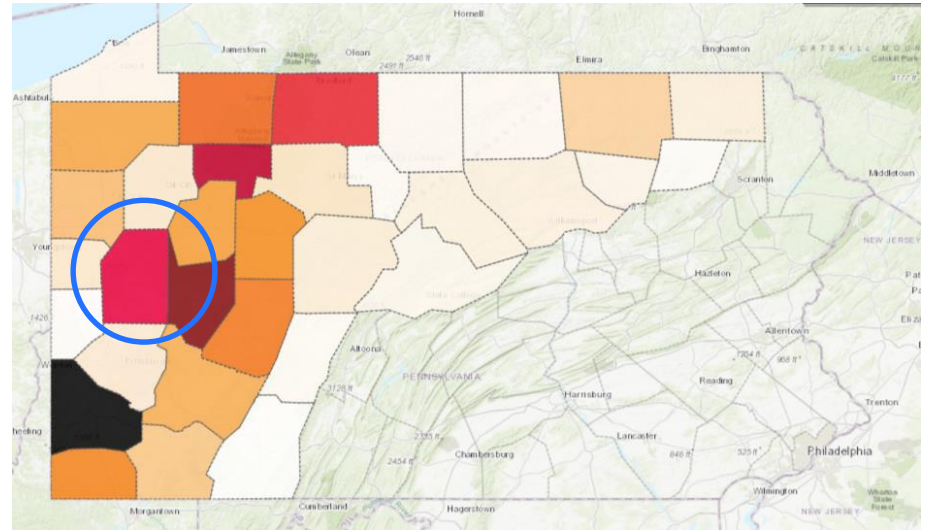

# Oil & Gas Air Pollution: Bradford County



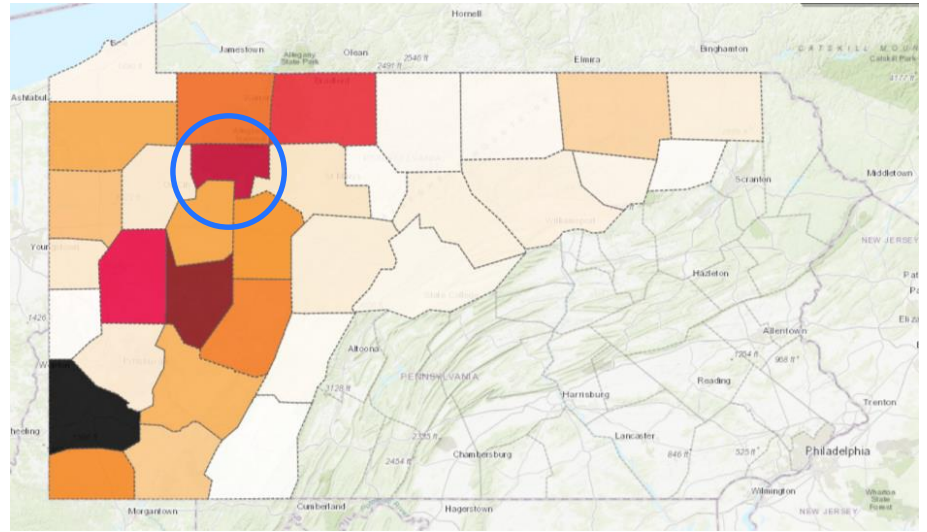

# Oil & Gas Air Pollution: Butler County



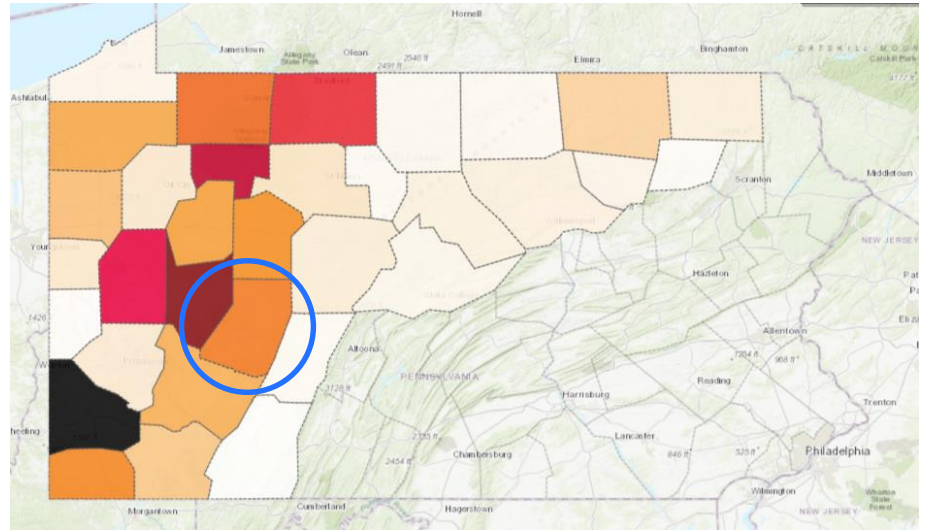

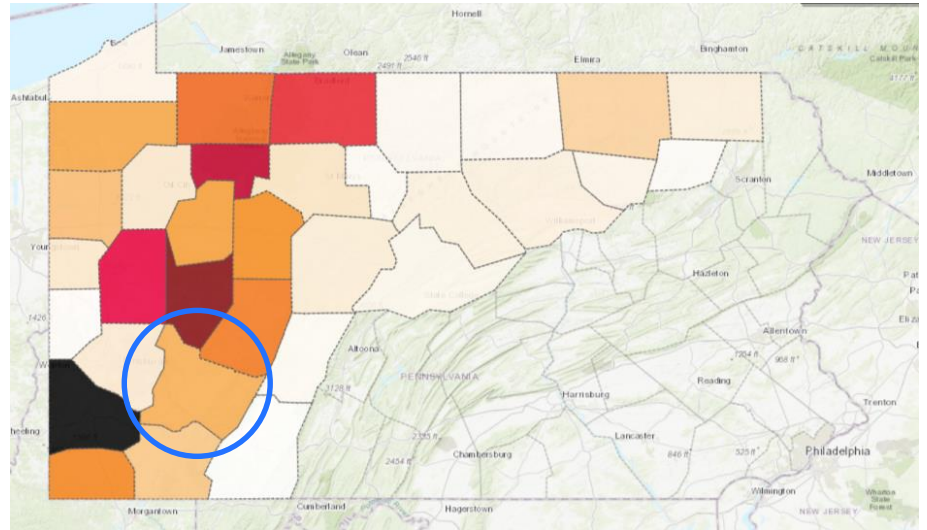
# Oil & Gas Air Pollution: Washington County
