**PETITION FOR REVIEW
of a final rule of the U.S. Environmental Protection Agency**

Pursuant to Rule 15 of the Federal Rules of Appellate Procedure and section 19(a) of the Toxic Substances Control Act (“TSCA”), the Alliance of Nurses for Healthy Environments, Cape Fear River Watch, and Natural Resources Defense Council, hereby petition this Court for review of the final rule of the U.S. Environmental Protection Agency (“EPA”) entitled, “Procedures for Chemical Risk Evaluation Under the Amended Toxic Substances Control Act,” which is published at 82 Fed. Reg. 33,726 (July 20, 2017) (the “Risk Evaluation Rule”). The Risk

Evaluation Rule was issued for purposes of judicial review on August 3, 2017. *See* 15 U.S.C. § 2618(a)(1)(A); 40 C.F.R. § 23.5. A copy of the Risk Evaluation Rule is attached as Exhibit A.

Petitioners have also filed a petition for review in this Court challenging a related EPA rule implementing TSCA. *See* Procedures for Prioritization of Chemicals for Risk Evaluation under the Toxic Substances Control Act, 82 Fed. Reg. 33,753 (July 20, 2017) (the “Prioritization Rule”). Because the legal issues raised by the challenges to the Risk Evaluation and Prioritization Rules substantially overlap, consolidation of the two petitions of review is appropriate, to promote judicial economy.
